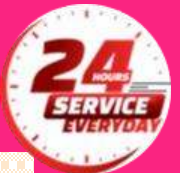

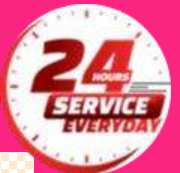

WHO CAN APPLY?
EMPLOYER OR APPOINTED EMPLOYMENT AGENCY (EA)

ELIGIBILITY FOR DP?
EP OR S PASS HOLDERS REQUIRED TO EARN A MINIMUM FIXED MONTHLY SALARY OF \$6,000

IS SPONSORSHIP REQUIRED FOR DP?
YES, DP IS SPONSORED USUALLY BY THE EMPLOYER

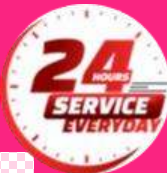

ELIGIBLE LTVP OR LTVP+ (ISSUED BY ICA) HOLDERS WHO WANT TO WORK IN SINGAPORE

LOC ELIGIBILITY?

LTVP / LTVP+ HOLDER WHO MARRIED TO SINGAPORE CITIZEN OR PR

IS MINIMUM SALARY REQUIRED TO APPLY LOC?

THERE IS NO MINIMUM SALARY REQUIREMENT

IS MINIMUM VALIDITY OF LTVP / LTVP+ REQUIRED?

YES, LTVP OR LTVP+ HAS TO BE VALID FOR AT LEAST 3 MONTHS

IS JOB TO BE SECURED BEFORE APPLY LOC?

YES, YOU MUST HAVE A JOB OFFER BEFORE APPLY LOC

LOC IS USUALLY TIED TO THE VALIDITY OF THE LTVP / LTVP+

IS LOC RENEWABLE?

YES, LOC IS RENEWABLE TILL THE VALIDITY OF THE (RENEWED) LTVP / LTVP+

IS LEVY APPLICABLE FOR LOC HOLDERS?

NO FOREIGN WORKER LEVY IS APPLICABLE FOR LOC HOLDERS

IS QUOTA APPLICABLE FOR LOC HOLDERS?

NO FOREIGN WORKER QUOTA IS REQUIRED FOR LOC

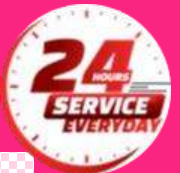

WHO IT IS FOR?
ELIGIBLE LTVP OR LTVP+ (ISSUED BY ICA) HOLDERS WHO WANT TO WORK IN SINGAPORE

PLOC ELIGIBILITY?
LTVP / LTVP+ HOLDER WHO MARRIED TO SINGAPORE CITIZEN OR PR

IS QUOTA OR LEVY APPLICABLE FOR PLOC HOLDERS?
NO FOREIGN WORKER QUOTA OR LEVY REQUIRED

IS MINIMUM SALARY REQUIRED TO APPLY PLOC?
THERE IS NO MINIMUM SALARY REQUIREMENT

WHAT IS THE VALIDITY OF PLOC?
PLOC IS ISSUED BY MOM ONLY TILL THE VALIDITY OF ICA'S LTVP / LTVP+

CAN PLOC HOLDER WORK FOR MULTIPLE EMPLOYERS?
NO. ALL WORK PASS HOLDERS MUST ONLY WORK FOR THEIR DESIGNATED EMPLOYER

IS JOB TO BE SECURED BEFORE OPTING IN FOR PLOC?
NO. YOU CAN BE EMPLOYED ONCE PLOC IS APPROVED BY MOM

HOW PLOC HOLDER CAN BE EMPLOYED?
EMPLOYER / EMPLOYMENT AGENCY (EA) CAN NOTIFY MOM BEFORE EMPLOYING

NOTIFY THE LAST DAY OF WORK?
EMPLOYER / EMPLOYMENT AGENCY (EA) CAN NOTIFY MOM

HOW TO APPLY FOR PLOC?
YOU NEED TO OPT IN WHILE APPLYING OR RENEWING YOUR LTVP/LTVP+ WITH ICA

WHEN PLOC WILL BE ISSUED?
ONCE YOU COLLECTED YOUR LTVP CARD, THEN MOM WILL ISSUE IT IF YOU HAVE OPTED IN WITH ICA

WHAT HAPPENS IF I DID NOT OPT IN WITH ICA WHEN I APPLIED / RENEWED MY LTVP?
YOU MAY BE STILL EMPLOYED WITH (NORMAL) LOC



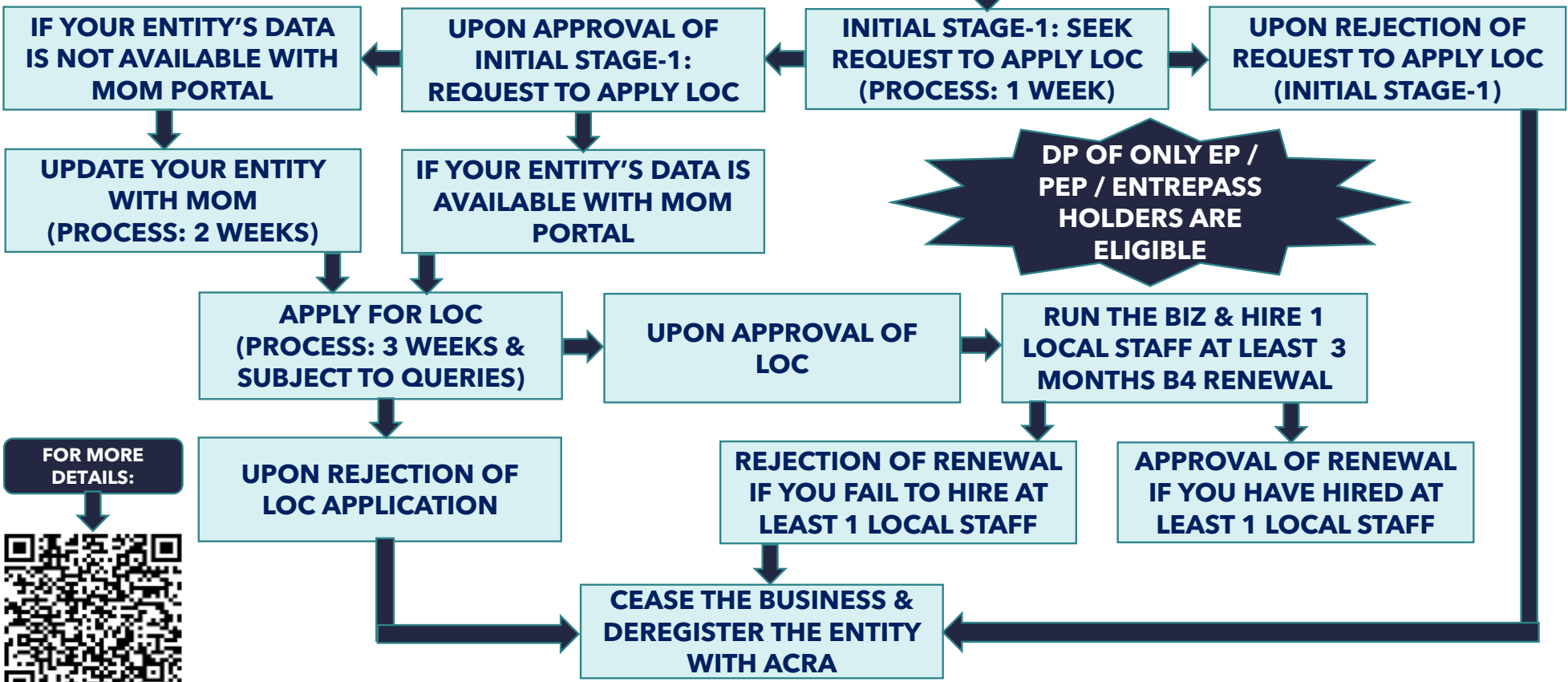
